

Terms and Conditions

of the purchase of discounted tickets and free entry to the District Museum in Toruń

Discounted tickets:

The following groups of persons are entitled to a discounted entry fee, upon presenting relevant documents:

- 1) students of schools in the education system, students of colleges of social workers, higher education students and doctoral students;
- 2) school students, higher education students and doctoral students being nationals of EU or EFTA Member States or the Swiss Confederation - parties to the EEA Agreement;
- 3) students of schools managed by social organisations abroad, registered in the base maintained by an authorised entity supervised by a relevant minister for education and upbringing, throughout the period of studying Polish, History, Geography, Polish Culture or any other subject taught in Polish, no longer than by reaching the age of 18;
- 4) students of schools operating in foreign systems of education, throughout the period of studying Polish, History, Geography, Polish Culture or any other subject taught in Polish, no longer than by reaching the age of 18;
- 5) students of Polish sections in schools operating in foreign systems of education, no longer than by reaching the age of 18;
- 6) students of European schools operating under the Convention on the Statute of the European Schools, signed in Luxembourg on 21 June 1994 (Journal of Laws of 2005, item 10) studying Polish, History, Geography, Polish Culture or any other subject taught in Polish, no longer than by reaching the age of 18;
- 7) persons over the age of 65, pensioners, persons collecting social pension and persons with disabilities accompanied by guardians, being nationals of EU or EFTA Member States or the Swiss Confederation - parties to the EEA Agreement;
- 8) teachers:
 - a) of schools and educational institutions, correctional facilities and juvenile shelters,
 - b) of schools operating in EU or EFTA Member States or the Swiss Confederation - parties to the EEA Agreement;
 - c) of schools managed by social organisations abroad, registered in the base maintained by an authorised entity supervised by a relevant minister for education and upbringing,
 - d) teaching Polish, History, Geography, Polish Culture or any other subject taught in Polish in:
 - of Polish sections in schools operating in foreign systems of education,
 - of European schools operating under the Convention on the Statute of the European Schools, signed in Luxembourg on 21 June 1994;
- 9) natural persons awarded a badge "For the Protection of Monuments", a badge of honour "Order of Merit in the Service of Culture", a badge of honour "Order of Merit in the Service of Polish Culture" or an honorary title "National Cultural Activist of Merit";
- 10) veterans,
- 11) persons holding the Toruń Seniors Card,
- 12) persons holding the Toruń Persons with Disability Card

Free entry:

The following groups of persons are entitled to a free entry to the Museum, upon presenting relevant documents:

- a) natural persons awarded the Order of the White Eagle, the War Order of Virtuti Militari, the Order of Merit of the Republic of Poland, the Medal for Merit to Culture – Gloria Artis;
- b) employees of museums entered in the National Register of Museums;
- c) members of the International Council of Museums (ICOM) or the International Council on Monuments and Sites (ICOMOS);
- d) holders of the Pole's Card (*Karta Polaka*), as referred to as in the Act on the Pole's Card of 7 September 2007 (Journal of Laws of 2014, item 1187, of 2015, item 1274, of 2016, item 753 and 2066 and of 2017, item 60);
- e) children under the age of 7;
- f) guardians of organised groups of more than 15 students,
- g) professional tour guides trained to guide tourists in Toruń,
- h) members of the Society of Friends of the District Museum in Toruń, upon presenting a valid membership card.

Documents proving that a visitor is entitled to a price discount or free entry to museums:

- 1) student cards (for primary and secondary school students, higher education students, doctoral students);
 - 2) pensioner's card;
 - 3) official cards documenting disabilities or degrees of disability;
 - 4) professional cards of persons referred to in point 4 paras. 8), 9), point 5 para. 2)
 - 5) cards confirming being awarded a badge, order or medal
 - 6) certificates or cards confirming veteran privileges;
 - 7) Membership Card ICOM and Membership Card ICOMOS;
 - 8) Pole's Card;
 - 9) documents proving the age of the visitor;
 - 10) other documents confirming the entitlement of persons referred to in points 4 and 5 to enjoy a museum entry fee discount, issued in Poland or in EU or EFTA Member States or the Swiss Confederation - parties to the EEA Agreement.
1. In cases not specified under points 3-4, the Director of the District Museum in Toruń may exempt a visitor from the fee or agree to an entry fee discount.
 2. A VIP Card holder together with accompanying persons is entitled to visit all exhibitions in the District Museum in Toruń free of charge by the date specified on the Card. The VIP Card is issued by the Director of the Museum and it contains the following information: serial number (from 1 to 500), full name of the holder and the Card's expiry date.
